

Spring River Wellness Center Privacy Policy

Protecting your private information is our priority. This statement of privacy applies to www.springriverwellness.org and Spring River Wellness Center and governs data collection and usages. For the purposes of this Privacy Policy, unless otherwise noted, all references to Spring River Wellness Center include www.springriverwell.org and SRWC. The SRWC website is fitness center site. By using SRWC website, you consent to the data practices described in this statement.

Collection of Your Personal Information:

In order to better provide you with products and services on our site, SRWC may collect personally identifiable information such as:

1. First and Last name
2. Email address
3. Address
4. Phone Number

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services on the Site. These may include; 1) registering for an account on our site 2) entering a sweepstakes or contest sponsored by us or one of our partners 3) signing up for special offers by selected third parties 4) sending us an email message 5) submitting your credit card or other payment information when ordering and purchasing products on our Site. To which we will use your information for, but not limited to, communicating to you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

Use of Your Personal Information:

SRWC collects and uses your personal information to operate its website and deliver the services and/or products you requested.

SRWC may also use your personally identifiable information to inform you of other products or services available SRWC and its affiliates.

Sharing Information with Third Parties:

SRWC does not sell, rent or lease its customer lists to third parties.

SRWC may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to SRWC, and they are required to maintain the confidentiality of your information.

SRWC may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on SRWC or the site; (b) protect and defend the rights or property of SRWC; and/or (c) act under exigent circumstances to protect the personal safety of users of SRWC, or the public.

Tracking User Behavior:

SRWC may keep track of the websites and pages our users visit within SRWC, in order to determine what SRWC services are the most popular. This data is used to deliver customized content and advertising with SRWC to customers whose behavior indicates that they are interested in a particular subject area.

Automatically Collected Information:

Information about your computer hardware and software may be automatically collected by SRWC.
